### Principal's Report

### Regional Cross Country 2021—Duncan Kirk, Yr4

Last week—again within hours of the state lockdown being issued, Year 4 student Duncan Kirk participated in a very fast Cross Country event in Warrnambool. Duncan finished midfield and was very pleased to have been able to enjoy the experience. Well done Duncan and a big thank you to Nic for getting Duncan to and from Warrnambool for his event—this probably won't be the last time this determined young man represents our school!

### Stephanie Alexander Kitchen Garden Program—Cooking fees

All outstanding fees must be paid up by next Friday 30th July. Teachers have sent reminder emails to parents who need to pay for their children's fortnightly cooking. The school is very flexible to providing the option of paying fortnightly (\$4 per child), by the term (\$20 per child) or for the year (\$80 per child).

### Electronic Signs for the School Crossing

These signs are now installed and functional, in Charlton Rd at either side of the Primary School. We are pleased to see these additional safety measures being provided for our school community.

### Get Active Kids Vouchers Program

Under the program, children may be eligible to receive up to \$200 to help with the cost of membership and registration fees, uniforms, and equipment. Special consideration also applies for children named on their own Australian Government Health Care Card or residing in care services as well as temporary or provisional visa holders, undocumented migrants or international students.

### Bridging the Digital Divide (BDD)

A letter to eligible students was sent home on Monday/Tuesday of this week. The timeline for this project is for allocated BDD laptops to be distributed by the end of Term 3. All acceptance sheets (regardless of your wish to accept or decline the offer) should be returned to the school by next Wednesday 28th July, for processing to commence. These can be scanned and emailed to the school email address for those at home.

Following the receipt of the acceptances from families, the School Council needs to purchase the replacement devices to ensure there is no gap in provision for students when at school. Depending on the delivery timeline, the BDD devices (current devices in classroom use) should be on course to be sent home with students before the end of T3. Further updates will be provided in due course.

### **CSEF**

Payment amounts this year are \$125 for eligible primary school students and \$225 for eligible secondary school students. Payments are made direct to the school to use towards expenses relating to camps, excursions and sporting activities for the benefit of your child.

Parent Teacher Interviews—August 2nd and 3rd

Interview time slots are available for booking through the COMPASS portal. In the event these are not permitted in a face to face setting, phone or Webex interviews will be offered. All families are expected to make an appointment with their child's classroom teacher. This year we have extended the opening times to cater to working families. As such bookings are available between 3.15-5pm and 6-7pm. If you have any questions about your child's academic progress, goal attainment or social/emotional adjustment - this is the opportunity to meet with your teacher to discuss these.

Specialist Paediatric Support Program

Did you know that St Arnaud Primary School has access to Dr Billy Garvey and Dr Claire Nogic from the Royal Children's Hospital in Melbourne, for the referral of students at our school?

If you have a developmental, medical etc concern for your child and do not have a regular paediatrician, we can refer your child for an appointment via telehealth. Waiting times are generally less than 2 weeks and all consults are free of charge. Please contact your child's teacher or myself if you wish to discuss your concerns. This is not a service available in all schools and we are exceptionally grateful to have access to this service.

### **CSEF** Application Form

#### CSEF ELIGIBILITY

Below is the criteria used to determine a student's eligibility for the Camps, Sports and Excursions Fund (CSEF).

#### Criteria 1 - Eligibility

To be eligible\* for the fund, a parent or legal guardian of a student attending a registered Government or nongovernment Victorian primary or secondary school must:

- on the first day of Term one
- on the first day of Term two
- · on the first day of Term three.
- Be an eligible beneficiary within the meaning of the State Concessions Act 2004, that is, be a holder of Veterans Affairs Gold Card or be an eligible Centrelink Health Care Card (HCC) or Pensioner Concession Card (PCC) holder, OR
- Be a temporary foster parent, and;
- Submit an application to the school by the due date.
- \* A special consideration eligibility category also exists. For more information, see: www.education.vic.gov.au/about/programs/Pages/csef.aspx

Parents who receive a Carer Allowance on behalf of a child, or any other benefit or allowance not income tested by Centrelink, are not eligible for the CSEF unless they also comply with one of (a) or (b) above.

#### Criteria 2 - Be of school age and attend school in Victoria

School is compulsory for all Victorian children aged between six and 17 years of age inclusive.

For the purposes of CSEF, students may be eligible for assistance if they attend a Victorian registered primary or secondary school. Typically, these students are aged between five and 18 years inclusive.

CSEF is not payable to students attending pre-school, kindergarten, home schooled, or TAFE.

#### Eligibility Date

For concession card holders CSEF eligibility will be subject to the parent/legal guardian's concession card being successfully validated with Centrelink on the first day of either term one (27 January 2021) term two (19 April 2021) or term 3 (12 July 2021).

#### PAYMENT AMOUNTS

#### CSEF payment amount

The CSEF is an annual payment to the school to be used towards camps, sports and/or excursion expenses for the benefit of the eligible student.

- Primary school student rate: \$125 per year.
- Secondary school student rate: \$225 per year.

The CSEF is paid directly to your child's school and will be allocated by the school towards camps, sports and/or excursion costs for your child.

For ungraded students, the rate payable is determined by the student's date of birth. For more information, see: www.education.vic.gov.au/about/programs/Pages/csef.aspx

Year 7 government school students who are CSEF recipients are also eligible for a uniform voucher. Secondary schools are required to make applications on behalf of parents so please register your interest at the school.

#### HOW TO COMPLETE THE APPLICATION FORM

### NOTE: ALL SECTIONS MUST BE COMPLETED BY PARENT/LEGAL GUARDIAN

Complete the PARENT/LEGAL GUARDIAN DETAILS section.

Make sure that the Surname, First Name, and Customer Reference Number (CRN) details match those on your concession card. You will also need to provide your concession card to the school.

If you are claiming as a Foster Parent or a Veteran Affairs Pensioner, you will need to provide a copy of documentation confirming your status as a temporary Foster Parent or provide your Veterans Affairs Pensioner Gold card to the school.

- Complete the STUDENT/S DETAILS section for students at this school.
- Sign and date the form and return it to the school office as soon as possible. The CSEF program for 2021 closes on the 13 August
